Used as part of a balanced fertility program, it assures that the nutritional demands of today's hybrids will be satisfied during the critical first 30 days of growth. Tri Z is a formulation that can be used in ammonium polyphosphate as well as pre-blended APP/liquid N combinations to prevent zinc deficiencies in the cool, wet soils of early spring, especially under minimum and no-till practices.

**DIRECTIONS FOR USE:** Use in accordance with recommendations of a qualified individual/institution. Do not allow to freeze. Always jar test for compatibility.

**Soil Application:** Apply 2x2 or at sidedress or topdress. Do not apply on seed.

**RECOMMENDED RATES:** This product should be used on the basis of a soil and/or tissue analysis. Suggested application rates are for one growing season (gallons per acre) in the absence of soil and/or tissue analysis.
