GENERAL INFORMATION: Foltec LQ Ultra 0-0-27 is a liquid applied potassium phosphite (K₂HPO₃) turfgrass fertilizer. This formula provides potassium which is important for cellular structure and plant energy production.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands in the driveway, sidewalk, or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

DIRECTIONS FOR USE: This product can be used with mechanical sprayers, ride-on sprayers and fertigation systems. Spray 1-5 ounces of this product with 1-2 gallons of water per 1000 sq. ft. Apply the solution uniformly over the total turfgrass area every 14-21 days. **Do not allow to freeze. Always jar test for compatibility.**
