GENERAL INFORMATION: Foltec LQ Classic 12-0-0 is a liquid applied high nitrogen (N) turfgrass fertilizer containing micronutrients. This formula contains a quickly available source of nitrogen plus iron and micronutrients for deep greening. Apply only to actively growing turf. Do not apply near water, storm drains or drainage diffiches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands in the driveway, sidewalk, or street, back onto your lawn. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices. Check with your county or city government to determine if there are local regulations for fertilizer use.

**DIRECTIONS FOR USE:** This product can be used with mechanical sprayers, ride-on sprayers and fertigation systems. Spray 6-12 ounces of this product with 1-2 gallons of water per 1000 sq. ft. Apply the solution uniformly over the total lawn area every Zi-28 days. For best results water thoroughly after application. Rates should not exceed 1 lib actual nitrogen per 1,000 square feet in a single application and usually not exceed 4 lbs. actual nitrogen total in a growing season. Single application rates during hot months should not exceed 1 lb N per 1,000 square feet of lawn and should always be irricated following application. **Do not allow to freeze. Always far test for compatibility.** 

Nitrogen Notice: For those states with nitrogen application restrictions, including but not limited to MD, NH, NJ, and VA, do not apply more than 0.7 lbs Nitrogen per 1,000 sq.ft.
