PRODUCT INFORMATION: Zinc 10% is a chelated micronutrient formulated for foliar or soil application. It is recommended for use as an additive in liquid fertilizers and is compatible with most herbicides, insecticides, and agricultural chemicals, Zinc 10% may not be compatible with some liquid fertilizer formulations.

DIRECTIONS FOR USE: Use in accordance with recommendations of a qualified individual/institution. Straight Zinc 10% should not be applied directly to the seed. Do not mix with liquid fertilizers high in orthophosphate. Do not allow to freeze. Zinc 10% is compatible with many crop protection products as a tank mix partner. The Andersons recommends a compatibility (jar) test before field mixing and application. Always read and follow all individual product labels before use. Soil Application: Apply 2x2 or at sidedress or topdress. Do not apply directly on the seed.

Foliar Application: Fill spray tank with water prior to adding fertilizer or other products. Use only as a supplement to a regular nutrient management program. Repeat applications may be beneficial. Use only as directed to avoid foliar burn. Do not apply when crop is excessively stressed for moisture or during periods of high temperatures. Use of a surfactant may enhance leaf coverage and increase nutrient absorption.

Mixing Instructions: UAN solutions: Zinc 10% can be mixed in any ratio with 28% or 32% urea ammonium nitrate (UAN) solutions.

NPK solutions: Generally, no more than 1 gallon of Zinc 10% should be added to 10 gallons of clear liquid mixed fertilizers such as 7-21-7, 10-34-0 or 11-37-0.

- For best results mix Zinc 10% as follows:
- 1. Partially fill tank with fertilizer and start agitation
- 2. Add Zinc 10% to circulating tank mix
- Add other pesticides or nutrients if compatible.
- 4. Fill tank and agitate throughly.

RECOMMENDED RATES: This product should be used on the basis of a soil and/or tissue analysis. Suggested application rates are for one growing season (gallons per acre) in the absence of soil and/or tissue analysis.
