Apply only as directed. Apply during the growing season. Andersons Golf Products Turf Fertilizer 19-26-5 is designed for use when establishing new turf. This product can also be used to correct phosphorus deficiencies in the soil.

Application Rates:

LOW:	2.40 lbs/1,000 sq. ft.
MEDIUM:	3.95 lbs/1,000 sq. ft.
HIGH:	4.80 lbs/1,000 sq. ft.

Cool Season Grasses:

Warm Season Grasses:

- Apply at the LOW, MEDIUM or HIGH RATE as determined by use or soil test.
