LIGHT: 3.0 lbs/1,000 sq. ft.  
MEDIUM: 4.0 lbs/1,000 sq. ft.  
HEAVY: 5.0 lbs/1,000 sq. ft.

  - Do not collect clippings for at least one mowing following application to avoid particle pick-up.

  - Exception: Apply at the LIGHT RATE when temperatures exceed 80°F.

- Warm Season Grasses:**
- Apply at the MEDIUM or HEAVY RATE.
  - Exception: Apply at the MEDIUM RATE when temperatures exceed 90°F.
