Apply only as directed. Apply during the growing season.

#### **Dilution Information:**

Determine desired application rate and the intended dilution. Add half of the total water to the tank. Activate sprayer agitator mechanism. Measure the appropriate volume of fertilizer concentrate and add to the spray tank. Water temperature will affect dissolution rate. Bring spray tank to total volume with water. Test compatibility before adding to the spray tank with other products. If tank mixing with pesticides, follow published guidelines for compatibilities and the order of chemical additions.

**TURF:** For use on all turfgrasses on golf course putting greens, tees, fairways, lawns, commercial grounds and other turf areas. **TREES & SHRUBS:** Two to three pounds of nitrogen per 1,000 sq. ft. per year are recommended for maintenance of landscape trees and shrubs. For best results, apply these levels of nitrogen over several applications made during the growing season. A minimum of 25 gallons of water per 1000 sq. ft. is recommended for this application.

**FLOWER BEDS:** Dissolve 8-10 oz. of fertilizer per 25 gals. of water or 1 tbsp. fertilizer per gallon of water. Apply 1-2 qts. of this solution per square foot of planted ground area for a thorough soaking of the soil. Repeat applications every 7-14 days.
