For All Applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to avoid particle pick-up.

Cool Season Grasses:

- Apply at the MEDIUM RATE.
- Exception: Apply at the LOW RATE when temperatures exceed 85°F.

Warm Season Grasses:

- Apply at the MEDIUM to HIGH RATE.
- Exception: Apply at MEDIUM RATE when temperatures exceed 85°F.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn.
