DIRECTIONS FOR USE
Apply only as directed. Apply during the growing season. Andersons Golf Products Turf Fertilizer 16-2-18 supplies a high level of potassium from potassium sulfate for soils low in this nutrient. Adequate potassium levels help promote root development and resistance to stress.
