DIRECTIONS FOR USE

Apply only as directed during the growing season. Apply when a regular feeding of nitrogen and potassium along with micronutrients is desired.

Application Rates:

LOW:	2.25 lbs/1,000 sq. ft.
MEDIUM:	3.50 lbs/1,000 sq. ft.
HIGH:	4.50 lbs/1,000 sq. ft.

For all applications:

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to prevent particle pick-up.

Cool Season Grasses:

- Apply at the MEDIUM RATE in the spring and fall months.
- Apply at the LOW RATE in summer months or when temperatures exceed 85°F.

Warm Season Grasses:

- Apply at the MEDIUM RATE during the growing season.
- Exception: If a higher nutrient level is desired, use the HIGH RATE.

Note: This product contains the micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. DO NOT WASH OFF WITH WATER.
