DIRECTIONS FOR USE: HCAS 20-0-0 can be applied to all cool and warm season turfs including golf courses, sports fields, commercial and residential lawns, sod farms, landscape ornamentals, nursery stock, row crops and specialty crops including fruits, nuts, vegetables, trees, shrubs, vines and flowers. Application rates and frequency are dependent upon soil and climate conditions present. See chart below for application rates.

DRY BROADCAST APPLICATION:

Apply to dry turf and irrigate thoroughly if applying at the 0.75 and 1.00 lb N/1,000 ft² rates.
