CARCINOGENICITY: None of the ingredients are known / listed carcinogens. However, the product may contain trace amounts of crystalline silica, which is listed by IARC as a potential human carcinogen. Imidacloprid has shown no evidence of carcinogenicity in animal studies. Imidacloprid is not listed by ACGIH, IARC, NTP, or OSHA.
