PRODUCT INFORMATION: Fulvic LQ is a high purity organic fulvic acid. This formulation contains a high concentration of the measurable fulvic fraction of humic substances, helping plants to better realize their full genetic potential.

PURPOSE: Fulvic acid is readily absorbed by leaves and roots, and enhances the absorption of nutrients and efficiency of plant metabolic processes.

DIRECTIONS FOR USE: Fulvic LQ is compatible with most liquid fertilizers. Use with appropriate water dilution. Jar test for compatibility before mixing with other chemicals. Formulation adjuvants may be incompatible and cause insoluble solids to form. Do not allow to freeze. Fulvic LQ is compatible with many crop protection products as a tank mix partner. The Andersons recommends a compatibility (jar) test before field mixing and application. Always read and follow all individual product labels before use. Fulvic LQ must be added to water prior to any fertilizer mixing in the tank. It may be applied through soil and foliar conventional methods such as, but not limited to in-furrow, banded, foliar, drip irrigation, water run or hydroponics.

Fulvic LQ is best mixed under continuous, mild agitation or circulation. When tank mixing with other ingredients, always start with water, Fulvic LQ, followed by (in order) fertilizer, herbicide, fungicide, insecticides.

Compatibility can be simply checked by:

- Mixing each product in a clear container in the same proportion to be used in the field
- Agitating for at least 60 seconds
- Visually observing for precipitate

STORAGE: Store in a cool, dry place out of direct sunlight. Avoid extreme high temperatures with no ventilation. Avoid contact with alkaline materials. Optimal storage temperatures are between 15 and 100 degrees Fahrenheit. If there is any sign of pressure build-up, contact the manufacturer.
