PRODUCT INFORMATION: The Andersons 14-0-0 Water Soluble fertilizer is a fertilizer that may be used throughout the growing season.

DIRECTIONS FOR USE: Use in accordance with the recommendations of a qualified individual or institution, such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication or apply according to recommendations in your approved nutrient management plan. Can be blended with other organic-approved liquid solutions such as humic acid, biologicals, and seaweed extracts. Always jar test for compatibility. This product can be applied V2. Danding, fertigation and foliar applications.

Apply only as directed during the growing season. Use in accordance with recommendations of a qualified individual or institution. Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to the area to be treated.

DRIP IRRIGATION APPLICATION or BANDING APPLICATIONS

Add the appropriate amount of material to the stock tank. Allow 2-3 minutes for material to activate then agitate. Note that temperature of water will impact rate of dissolution. Typical weekly nutrient program per acre (0.4 hectare):

Seedlings: 4-8 lbs (1.81-3.63 kg) Vegetative: 10-20 lbs (4.53-9.07 kg) Flower: 6-12 lbs (2.72-5.44 kg)

FOLIAR SPRAY APPLICATION

Add water to spray tank first then add product to tank, allowing at least 3 minutes for product to activate. Agitate tank prior and during application. Apply by a spray method and in an adequate amount of water that will provide complete coverage of the plants. Apply amounts based on nutrient deficiencies at a rate of 1-10 pounds (0.45 kg) per acre (0.4 hectare) a maximum frequency of weekly during the growing season. If using in a spray program with other materials, please do a compatibility jar test to ensure materials do not react and settle solids.

Solubilizing into a liquid concentrate (water temperature of 70°F)

3% concentrate – add 2.3 pounds per gallon of water with mechanical agitation 5% concentrate – add 4.6 pounds per gallon of water with mechanical agitation Note – max concentration is 6 pounds per gallon but requires continuous agitation
