GenesisRx Zeolite+ delivers NPK, secondary and minor element fertility, Humic acid, Zeolite dispersible granules and beneficial microorganisms all in one easy to apply product.

Purpose: Humic acids may increase the uptake of micronutrients.

Note: This product contains micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. DO NOT WASH OFF WITH WATER.

Directions for use

Aerification: GenesisRx Zeolite+ is recommended for application following your normal aerification program. Typical application rates range from 20-30 pounds of product per 1000 sq ft. Product may be placed into aerification holes via drag mat or broadcast applied in conjunction with sand topdressing. GenesisRx Zeolite+ may also be used in conjunction with Genesis Rx 5-7-5 in a two-step application process. First, GenesisRx Zeolite+ should be placed into aerification holes via drag mat or in conjunction with sand top dressing at an application rate of 10 pound per 1000 sq. ft. Next, broadcast apply Genesis Rx 5-7-5 at 10 pounds of product per 1000 sq. ft. If desired, GenesisRx 5-7-5 can be applied 7-14 days prior to aerification to stimulate turfgrass growth and subsequent recovery.
