DIRECTIONS FOR USE: 34-0-6 Fertilizer with CarbonCoat™ can be applied to all cool and warm season turfs including golf courses, sports fields, commercial and residential lawns, sod farms, landscape ornamentals, nursery stock, row crops and specialty crops including fruits, nuts, veg-etables, trees, shrubs, vines and flowers. Application rates and frequency are dependent upon soil and climate conditions present. See chart below for application rates. Apply only as directed. Apply during the growing season.

Apply only to actively growing turf. Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn.
